## A NEW TYSON FRESH MEATS PLANT

Located in Utah County, Utah, as part of the Provo-Orem metropolitan area, the Eagle Mountain plant is Tyson Fresh Meats' fifth case ready plant in the nation and the largest case ready facility in the U.S. to date.

Tyson Fresh Meats' case ready plant produces what consumers commonly see in the meat case of their local grocery store but on a much larger scale. The meat cutting and packaging operation takes large cuts of beef and pork and portions them into consumer-friendly sized steaks, chops, roasts and ground meats. These convenient packages are weighed, labeled and shipped to retailers across the country for the stocking of grocery, club and superstore meat cases.


## Continued Alignment

The state-of-the-art Eagle Mountain facility also allows Tyson Fresh Meats to shift volume across its other nationwide Fresh Meats case ready production facilities in Sherman, Texas; Council Bluffs, Iowa; Goodlettsville, Tenn. and Columbia, S.C.

"With packaging and product sustainability evolving, this will give us the upper hand in serving our customers well," Meyer said.

"Great work is being done and will be implemented in these new plants over the next several years."

Built to support case ready business and customers alike, the facility in Eagle Mountain is opening the door to new program opportunities.

Its capacity to grow alongside current and new customers as well as implement

new packaging and production technology will be a huge opportunity well-positioned for advancement and will help meet growing consumer demand for fresh, high-quality case ready beef, pork and grinds.
